Patricia Vondal: Have you considered conducting longitudinal assessments to judge impact of approach over time on target population groups in any countries?

Indra Klein: Regional livelihood officers: What % are locals? Thoughts on buy-in, especially where there may be tensions among neighboring locals?

Pam: I see livelihoods as referring to more low-level subsistence economic activity - is that fair? Because if so, I am wondering how you/if you make the link between MERS for livelihoods and more sustainable job creation, SME development and market development (i.e. sectoral growth, etc.).

Pam: Can MERS be used as a useful steppingstone in market evolution in that way, and do you have examples?

Charlin - Marketlinks: Thanks for the great questions, folks.

Phil - Mercy Corps: What sort of work has been done to integrate MERS with graduation approach programming?

Indra Klein: With regard to private partnerships (local/regional businesses that either rely on small stakeholder as supply chain or provide services/products to small stakeholder) thoughts on best practices in vetting and minimizing&/or ensuring any "corrupt"/unfair market scenarios?
