I would expect that each should be able to pay for itself with the revenue from users but most rural users are not high and steady income earners.

Paul Kweheria: Could one of the presenters speak more about how they are evidencing 'additionality' especially in East Africa?

Frank: Thanks for the examples. I asked because public sector incentives have been instrumental in the development of alternative energy in Western nations.

Max: Has anyone been following the blended finance approach in Somalia by a program called Shuraako? It seems to have a successful model for conflict-affected contexts.

Tekalign Kelbessa: From the experiences done does the investors and lenders liked the blended financing?

Joshua Nthakomwa: We are working toward developing a facility for private sector companies as off-takers from aggregated smallholder farmers using a blended finance as a support and incentive. If

there's one critical lesson you can provide from your experience with regard to what we are looking at, what would that be?

Joan Larrea: Joshua, having the offtaker have skin in the game, being very low in the seniority of the structure along with or adjacent to the donors, adds a lot of credibility. Our case study on the Tropical Landscapes Finance Facility in Indonesia may hold some info, even through it is for a rubber plantation and not for smallholders.

Joshua Nthakomwa: Thanks Joan. What do you mean by the offtaker having skin in the game and being very low in the seniority structure?

Aldo Soto: Hello, we're structuring a Development Impact Bond to support agricoops change to climate smart agri production models

Aldo Soto: We'll be implementing it in the Peruvian Amazon

Joan Larrea: Meaning that if things go wrong, the offtaker is one of the first to take the financial hit,
