grants" really covers all financial support.

Anastasia de Santos: So including matching grants and lines of credit.

Geetha Nagarajan: Thanks.

Eugenia Durán: How do you measure job creation for micro business in Latin

America? How can you measure?

Anastasia de Santos: Eugenia, this review does not cover microenterprise (fewer than

5 employees).

Eugenia Durán: Thanks!

Anastasia de Santos: But how the studies do it is count the number of full time

equivalent employees.

Anastasia de Santos: Can I ask where you are joining us from, organizationally?

Anastasia de Santos: Thank you.

Geetha Nagarajan: What are the outcomes that were suitable for a meta-analysis?

Jobs? Revenues?

Jina Krause-Vilmar: Hi, this is Jina from the Near East Foundation. How is firm

performance measured?

USAID Microlinks: Thanks, Geetha and Jina.

USAID Microlinks: We've recorded these questions.

USAID Microlinks: Joao is talking now.

Siddier Chambers: Thanks Caio that was revealing...evaluation is vital.

Siddier Chambers: However, who should conduct evaluation of NGOs and Govt

programs?

USAID Microlinks: Thanks, Siddier! We have your question recorded.

Siddier Chambers: Additionally, what would you recommend as the most effective

evaluation framework?

Anastasia de Santos: Siddier, what would you want to use this framework for?

Anastasia de Santos: Generally as Caio mentioned, having a counterfactual is key.

Anastasia de Santos: So some kind of control group.

Anastasia de Santos: Ideally randomly selected, or else matched based on specific

variables.

Jennifer Bremer: It would be interesting to test whether the staff are in fact good at

creaming by measuring their expectation of a firm's likelihood to

benefit vs. actual benefit.

Jennifer Bremer: Also, would be nice to see if services are delivered to firms

individually vs in groups; as one would expect firms to learn from each other and strengthen their social network. Comment?

meta-analysis? There are many defendable model-based evaluations that (statistical) control for confounding variables.

Christopher Nicoletti: Also, I don't imagine that everyone will be interested in this, but

I would be very interested in how he established the quality weight for each paper that is included in the analysis. Is there a

place for me to find more detail on this?

and women, what aspect of MGS would you associate with these

weaknesses of the current approach to MGS? Thank you.

(within-project)? I.e., learning to do it better?

Geetha Nagarajan: by yielding to what sponsors want, aren't researchers bending

the rigor and trying to measure that is not measurable well?

USAID Microlinks: Eugenia, Thanks for the question. If you're able to provide a

translated version of your question into English we'd greatly

appreciate it.

USAID Microlinks: We want to make sure we respond to it.

paper and I am curious to know if the MGSs targeted the higher performing firms could this ultimately lead to a larger public good in the form of higher employment, multiplier effects, etc. It would be interesting to follow the firms over time and see what the public benefits are for firms that are less likely vs. those that

are more likely to be aware.

Jennifer Bremer: If we "know" that gazelles in fact create almost all the jobs, why

not recommend targeting them preferentially rather than both the

small/struggling and gazelles?
